The program was facilitated by Social workers of CN Prakash B.K. The saving is done through ECD mother groups in each school. Initiations of saving program have encouraged mothers in their regular participation in ECD classes.

Child Nepal with support of Caritas Germany organized one day orientation on Human Trafficking to VCPC members on 27th September, 2016 in VDC office, Kunchok, Sindhupalchok. The program was facilitated by Program Coordinator, Ms. Furba Jangmu Sherpa. The objectives of the program were to orient VCPC members about anti child trafficking and its trends, to inform participants about (RECOVERY) project and to aware VCPC members about their roles and responsibility on child protection in the local level. Through the program the VCPC members are aware about the issue of child trafficking, its forms, national and international laws and policies regarding child protection from anti child trafficking. Moreover, the VCPC members are sensitized about their roles and responsibilities towards protection of children in the local level.



## ECD Mother Group Formation and its regular Meetings

Child Nepal formed three ECD mother groups in three schools and regulated monthly meeting of five ECD mothers group under child protection, Education and livelihood (Recovery) from 16-23 September, 2016 in Kunchok VDC, Sindhupalchok. meeting to discuss the issues of children and mothers of ECD. During the formation, the presentation was done on the roles, responsibilities and importance of ECD mothers group. In addition, the new RECOVERY project, its objectives, project area/schools, expected results and activities were introduced among teachers and mothers group. Child Nepal organized one day program with Village Committee to Control Human Trafficking (VCCHT) on 26th September 2016 at VDC Office, Kunchok, Sindhupalchok with the support from Caritas Germany. The program reformed the VCCHT and orient the members about their roles and responsibilities to control human trafficking in local level. After the completion of program, the VCCHT members had common understanding about the roles and responsibilities of the committee. The meetings was productive enough in generating common understanding and exploring the issue of children in kunchok VDC. The program guided VCCHT members about the formation process of VCCHT, its activities, their roles and responsibilities.



## YOUTH MARATHON AGAINST CHILD TRAFFICKING

Child Nepal in collaboration with PLAN International Nepal organized youth marathon in Kiul VDCs to mark the 10th National Human Anti-trafficking Day. The objective of organizing the program was to sensitize local youths on anti-trafficking and engage them to combat child trafficking in local level. The program succeeded to provide massive awareness on anti- trafficking among the youth targeting more than 400 participants.

# Psycho-Social support and life skill education

Child Nepal organized orientation on psycho-social and life skill education for the community people and guardians in four VDCs and for adolescence boy and girl at Kiul VDC of Sindhupalchok respectively under the FACTIVE on September. The event aware the participants by providing orientation on 10 life skill education and motivate them in schooling for higher education and motivate them

In addition, the participants were given orientation on identifying the victims and treating according to their problems. The total participants were 164 and among them 80 were male and 84 were female. The participants got knowledge on treating and supporting the vulnerable children and children who are at risk of vulnerable. It was supported by PLAN International Nepal.

## Parent Session on Child Protection

Child Nepal with the support of Plan International organized four parent sessions in Thankpalkot, Thankpaldhap, Bhotenamlang and Lagarche VDCs on child protection under the FACTIVE project. The main objective of the program was to aware parents on child

CN in collaboration with Catritas Germany organized an interaction program with District Child Club Members (DCCN) on 25 October 2016 at Chautara Sindhupalchok. The DCCN members presented

that the situation of trafficking is very high after the earthquake and specific campaign need to be launched to combat it. The program was facilitated by Ms. Furba Jangmu Sherpa.
